
POWER DISSIPATION:Pd(%)




CLAMPING VOLTAGE:Vol(V)

TRANSIENT THAERMAL IMPEDANCE:R<sub>th</sub>(°C/W)






# Characteristic Curves









## Precaution for Mounting / Circuit board design

- 1. When a highly active halogenous (chlorine, bromine, etc.) flux is used, the residue of flux may negatively affect product performance and reliability.
